No. 18/93/2015-3C1:- In pursuance of the provisions of Rules 3, 7 and 9 of the Haryana Municipal Corporation Delimitation of Ward Rules, 1994 and in supersession of all previous orders/notifications issued in this behalf, the Governor of Haryana hereby publish the following proposal for the delimitation of wards of **Municipal Corporation, Faridabad, District - Faridabad** for information of the persons likely to be affected thereby.

Notice is hereby given that the proposal will be taken into consideration by the Government on or after the expiry of a period of 10 days from the date of publication of this order in the Official Gazette, together with the objections and suggestions, if any, which may be received by the Principal Secretary to Government Haryana, Urban Local Bodies Department / Director, Urban Local Bodies, Haryana, Panchkula through **Deputy Commissioner, Faridabad** from any person in respect of the proposal before the expiry of the period so specified:-

Schedule of Boundaries

Ward No. 01 :- Starting from the point of Delhi-Mathura Road where the Southern limit of Municipal Corporation, Faridabad intersects Delhi- Mathura Road towards North along the Delhi-Mathura Road to JCB Chowk, thence moving towards west on 200 ft. wide Road of Sector-25 to the junction of Sohna Road, thence moving towards western side on Sohna Road upto southern-eastern side of H.No.198-Gupta Sadan on the corner of Mother Dairy of Jeewan Nagar (Gaunchhi), thence moving towards southern side of house No. 176/696 of Sh. Shish Pal Tanwar on the corner of Jeewan Nagar, Gaunchhi, thence moving towards southern-eastern side upto Gopal Khal Bhandar opposite the corner of Kali Mata Mandir on Gaunchhi School Road, thence moving towards western side of this Road upto House of Sh. Aash Mohammad Khan, thence moving towards southern side on East of Gaunchhi Talab upto the corner of Gola Chowk, Kumhar Mohalla Gaunchhi, thence moving towards western side on the rasta going to Partapgarh across the Puliya on the corner where this Road intersect to Gouchhi drain, thence moving alongwith western side limit of Municipal Corporation, Faridabad upto the point where the southern limit of Municipal Corporation, Faridabad intersects to Delhi-Mathura Road, which is starting point.

Ward No. 02 :- Starting from JCB Chowk on Delhi-Mathura Road, moving towards North direction on this Road crossing Ballabgarh Railway flyover upto Mujesar Mod on Delhi-Mathura Road, thence moving towards West direction on Mujesar Railway

Phatak Road upto across the Mujesar Phatak, thence moving towards North on western edge of Railway line upto the point where it intersects to Road under the Bata Flyover, thence moving towards Western side on 200 ft. wide Road situated on north of New Industrial township upto Pyali Chowk/Baba Deep singh Chowk, thence moving towards western side on Airforce Road upto the turn of last street of New Janta Colony, thence moving towards south upto Shiv Mandir which is located on southern-eastern side on 27 ft. wide Road upto the house of Sh.Ashok Kumar, thence moving towards southern-eastern side on 27 ft. wide Road upto the Road leading to New Janta colony, thence moving towards east on police Chowki Road of New Janta Colony upto the intersection of 200 ft. wide Road located on western side of New Industrial Township at the corner of street leading to Sant Ravidass Mandir, Vill. Saran, thence moving towards southern side on 200 ft. wide Road upto the western side and then southern side of boundary wall of Press Colony upto the point where it intersect the Gaunchhi Drain, thence moving towards north-west direction across the Gaunchhi Drain on south-west edge of Gaunchhi Drain upto the north-east corner of Disposal of Press colony, thence moving towards South-East direction on the Road upto the corner of Fish market, thence moving towards South-East direction on the Road in front of Fish market upto the north-east corner of Power House Colony, Sector-22, thence moving towards south on boundary wall of Power House Colony upto north-west corner of this colony, thence moving towards west from this point on southern boundary wall of Power House Colony upto the junction of Hardware Chowk-Sohna Road which is also a south-east corner of this colony, thence moving towards south direction on Hardware Chowk to Sohna Road upto the point where this Road meet to Ballabgarh-Sohna Road, thence moving towards east on Sohna Road up to where it intersect with the Sector dividing Road of Sector-24 and Sector 55, thence moving towards south on 200 ft. wide Road located on eastern side of Sector 55 and western side of Sector-25, thence moving towards east up to Delhi-Mathura Road at JCB Chowk, which is the starting point.

Ward No. 03 :- Starting from Techno Battery, House Sanjay Colony, Sector-23 which is a south-east corner of Power House Colony upto the Sohna Road junction, thence moving towards West on Sohna Road upto the Gate of Apna Ghar Colony, thence moving towards North on Apna Ghar colony Road up to the southern edge of Gaunchhi Drain, thence moving towards east on northern edge of Gaunchhi Drain upto Pulia of Sector-52, thence moving towards east across the Pulia upto eastern edge of Gaunchhi drain, thence moving towards north on eastern edge of Gaunchhi drain upto house of Sh. Ram Badan, thence moving towards west upto the shop of Sh. Santosh s/o Sh. Baljeet, thence moving towards south upto the Bhardwaj Medical Store on street no.42 of Sanjay colony, thence moving towards East upto Jindal Cloth House, thence moving towards north on the Road located on east of

Jindal Cloth House on Street No. 12 upto house of Sh. Anil Kumar, thence moving towards East upto house no. 2033 of Sector-23A, thence moving towards South upto H.No.1941 of Sector-23A, thence moving towards northern side on Road located between Sector-23A developed by Municipal Corporation, Faridabad and Sanjay colony upto the house of Sh. Bhagwan Dass, thence moving towards North upto the house of Sh. Arjun, thence moving towards east upto Techno Battery House, Sector-23, which is the starting point.

Ward No. 04 :- Starting from Techno Battery House, near North-East corner of Power House Colony, Sector-23, thence moving towards west on the boundary wall of Power House colony upto House No. 1744, Sector 23A, thence moving towards south on Road between Sanjay colony and Sector-23A upto House No. 1941, Sec-23A, thence moving towards west upto House No. 1957 of Sector 23 A, thence moving towards North from the corner of Gali no. 12 upto the corner of House No. 2033 Sector 23 A, thence moving towards West on of Gali No. 12 upto house of Sh. Anil Kumar located on 22 feet Road of Sanjay Colony, thence moving towards South on 22 ft. wide Road Gali No. 42 upto Jindal Cloth House, thence moving towards west through Gali No. 42 of 33 ft. Road up to Bharat Medical store, thence moving towards North on 33 Ft. Road upto shop of Shri Santosh S/o Shri Baljit, thence moving towards West upto the House of Sh. Ram Badan H.No. 967 Sanjay colony, thence moving towards North-west direction on Western edge of Gaunchhi drain up to North-East corner of disposal of Press colony, thence from this point moving towards south-east on this Road up to the corner of Fish Market, thence moving towards south-east direction on northern boundary wall of Power House colony up to North-east corner of this colony, thence moving towards south on boundary wall of this colony up to south-east corner of this colony, thence moving towards west on this boundary wall up to the junction of Hardware-Sohna Road, thence moving towards South on Hardware-Sohna Road up to Techno Battery House located on this Road, which is the starting point.

Ward No. 05 :- Starting from the North-East corner of Disposal of Municipal Corporation which is situated on Ballabgarh-Sohna Road, thence moving towards North upto the house of Sh. Bal Ram located on the corner of Netram Saria wali gali in North of Parvatiya Colony, thence moving towards East upto the corner of Shivaji School, thence moving towards North upto the H.No 103 of Anita Devi, thence moving towards East upto the H.No 1142 of Sh. ChhattarPal, thence moving towards North upto the corner of shop of Raj Electricals, thence moving towards East upto Rajmal House, thence moving towards North upto fruit shop of Raju Fruit wala on 60 Ft. wide Road near B.N. Public School, thence moving towards East side on Road of Kurukshetra Sr. Sec. School upto Shivam Juice Corner which is situated on the corner of Gurudwara Road, thence moving towards North on Gurudwara Road upto
